The aim is the creation or optimization of protective measures in relation to the evaluated security risks of an existing system of premises and their assets protection.

Security evaluation is a process which on the basis of investigation determines the conditions of protection at the premises of reference. Subsequently, based on investigation and analyses, suggests optimisation actions.



## WHAT DOES SECURITY ASSESSMENT INCLUDE?

1. **Preparation of a security investigation – review of materials, collection of information, identification of the problem.**
2. **Physical investigation directly at the premises by a G4S team – focused at the premises as a complex or at the problematic part.**
3. **Analysis of the security environment of the premises** (location, identification of sources of risks, availability, accessibility).
4. **Characteristics of the premises of reference** (activities of the firm, security policy, assessment regarding security).
5. **Assessment of the current condition of the premises protection system** – (Technical Security Features, Mechanical Security Features, Manned Security, Regime and Organization Measures)
  - 5a. **Assessment of Technical Security Features (TSF) and Mechanical Security Features (MSF):**
    - » **Perimetric protection, MSF** (fence, entrances into the premises, etc.), **TSF** (CCTV), Automatic number plate recognition (CCTV), ACS, perimetric detection systems, etc.
    - » **Shell protection, MSF** (panelling of openings – gates, doors, turnstiles, windows, emergency exits), **TSF** (monitoring CCTV, AS – Alarm Systems, ACS – Access Control Systems, etc.).
    - » **Space protection, MSF** (entrances into corridors, rooms, internal doors), **TSF** monitoring (CCTV, AS, FDS – Fire Systems, Stable Fire-Fighting Device, ACS, etc.).
    - » **Object protection** (vaults, security boxes, protection of pieces of art, combination of TSF and MSF).
    - » **Integration software.**
  - 5b. **Assessment of manned guarding performance:**
    - » TSF operation, inspection activities, supervision over whether regime and organization measures are met, guard patrol activities, recording activities, required knowledge, equipment, level, quality, etc.



### 5c. Assessment of Regime and Organization Measures:

- » Instructions for the performance of services, regulations of a client, reports, regime of entry/access into the premises/buildings. Regime and movement of persons/vehicles within the premises according to individual security zones. Regime of the movement of employees, suppliers, visitors, key management, etc.

### 6. Process of security risks assessment, which is based on a current conditions of protection, includes:

- » Preparation of a list of identified security risks.
- » Analysis of security risks (determination of the materiality of risks based on probability, consequences and their harmonization with the use of suitable methods: matrix likelihood/consequence the analysis of causes and consequences, investigation of incidents from the past, model situations and expert estimations).
- » Evaluation of security risks.

### 7. Optimization suggestions aiming at the reduction of security risks in the form of suitable security measures.
